### FAIR ADMISSION INFORMATION

4-H members who are **ONLY** exhibiting in 4-H Family & Consumer Sciences (FCS) will receive two (2) admission tickets. Admission tickets are good for admission one (1) day of the Fair. *(4-H members who are exhibiting livestock AND FCS will receive two (2) admission wristbands, good for each day of the Fair.)* 4-H members who are **ONLY** exhibiting in FCS will receive their admission tickets when they deliver their exhibits to O'Connor Field House on Monday, July 21 from 3:00 - 7:00 p.m.

### General Rules & Information

1. Canyon County Fair Management reserves the final and absolute right to interpret these rules and regulations, and settle and determine all matters, questions, and differences in regard thereto, or otherwise arising out of, connected with, or incident to the Fair.
2. Exhibitors are required to familiarize themselves with all rules. Exhibitors or their representatives failing to comply with any of these rules are subject to forfeiture of all awards and could lead to immediate dismissal from Fair and/or not being allowed to exhibit in future Fairs.
3. Disrespect shown to any judge or Fair official by an exhibitor or their representative will result in forfeiture of all awards made to the offending exhibitor and that person and/or their representatives will be asked to leave the Fairgrounds.
4. No literature may be distributed on the Fairgrounds or in the buildings unless permission has been given by Fair Management.
5. **LIABILITY** - Exhibitor/owner of livestock/horses/exhibits assumes all risk and responsibility for loss, theft, and damage to his/herself or his/her property, or injury to any person or the property of any person by animal, while the animal/exhibit is on the Fairgrounds. The owner or custodian of property of any kind brought to the Fairgrounds whether for exhibit or for other purposes assumes, as a condition of its admission to the Fairgrounds, all risk of and responsibility for loss, damage, or theft. Exhibitor exempts the Canyon County Fair, its officers, directors and employees from liability for any loss, damage, or injury to any person or the property of any person or any animal owned or exhibited by him/her and shall indemnify the said Canyon County Fair against all claims and any injuries or damages arising from actions or negligence of the exhibitor.
6. Refer to specific department for additional rules.

## **4-H Family & Consumer Sciences Rules**

1. All general rules and regulations apply to Family and Consumer Sciences (FCS).
2. All 4-H activities at the Canyon County Fair are governed by the current version of the Idaho 4-H Policies and Procedures. Copies are available at the Canyon County Extension Office or online at: [www.uidaho.edu/extension/4h](http://www.uidaho.edu/extension/4h).
3. All exhibitors, parents and adults working with 4-H youth must follow the Code of Conduct as listed in the Idaho State 4-H Policies and Procedures.
4. 4-H Participation - To be enrolled in competitive 4-H events, projects and activities, an individual must be 8 to 18 years old at the beginning of the calendar year (January 1 of the current year).
5. 4-H Cloverbuds (5 to 7 years old on January 1 of the current year) are eligible to exhibit non-competitive Family & Consumer Science projects.
6. **FCS entries must be submitted online by Tuesday, July 1.** An entry fee of \$2.00 per item entered is due through the online submission website provided by the Canyon County Extension Office. Late entry fees are \$10.00 per item.
7. 4-H Superintendents will rely on the signatures of the 4-H leader and parents as a certification to the record book and that the exhibit is complete and ready to be judged. A project oral presentation is required. Exhibits will not receive an award if the record book is not signed. The 4-H member, leader and parent(s) must sign all record books.
8. Record book portfolios are optional to display and are not part of the judged exhibit. If choosing to display, do not include any personal contact information.
9. A judge will evaluate all clothing, miscellaneous & foods exhibits and award a purple, blue, red, or white ribbon. Exhibits will be judged separately from the interview evaluation and record book.
10. 4-H members may exhibit two items per project. One item must fulfill the exhibit requirements for the project as described in the Idaho 4-H Project Requirements Handbook. A second item must demonstrate something else a youth learned in that project during the current project year.
11. Award of Excellence is awarded to only purple or blue ribbon exhibits within a project area.
12. Thank you notes - All award winners are required to write a thank you note to award sponsors before receiving their awards. FCS thank you notes need to be turned into the 4-H Department in O'Connor Field House.
13. **DRESS CODE** - 4-H youth are representing their program at all times during the Fair. Appropriate dress will be worn in all 4-H areas. Inappropriate attire includes exposure of underwear or midriff area, spaghetti strap or see-through shirts, jerseys, and short shorts.

## **4-H Grievance Policies & Procedures**

14. Grievances will be considered only if there has been a violation of General Rules, 4-H Rules or Department Rules, or if an exhibitor feels they have not received fair and equitable treatment. Decisions of judges are final, no grievance can be filed.
15. Grievances must be accompanied by a deposit of either \$100.00 cash, cashier's check, certified check, or official check made payable to the Canyon County Extension Office. The deposit will be returned if the grievance is upheld. If the grievance is upheld, the violator may be held liable for any portion of the direct costs incurred by the Fair or Canyon County Extension in the course of the grievance resolution. Failure to reimburse the Fair or Canyon County Extension shall be cause for disallowing future entries in the Fair.
16. Given the short duration of the Fair:
  - a. The exhibitor or representative shall make every effort to file the grievance prior to judging. All grievances must be filed within 24 hours of the time of the cause of the grievance.
  - b. The Grievance Committee (comprised of a representative from the Canyon County 4-H Leaders Council; Canyon County Fair Advisory Board; Canyon County Extension Educator; Canyon County 4-H Program Coordinator) will make every effort to resolve grievances as quickly as possible. All exhibitors by entering an exhibit and all persons by filing a grievance agree to cooperate with the Grievance Committee to resolve the grievance in a timely manner.
17. Any exhibit involved in a filed grievance before or during the judging is eligible to compete until the grievance is resolved.
18. Classes that involve a grievance exhibit will not become official until the grievance is resolved.
19. At the discretion of the Grievance Committee, judging can be delayed to allow time for the grievance to be resolved if doing so does not unreasonably delay or disrupt the operations of the remainder of the fair judging.
20. No grievance will be accepted unless it:
  - a. Is filed or received in writing and signed;
  - b. Clearly states which rule(s) has been violated;
  - c. States when the exhibitor or representative first became aware of the facts and rule violation;
  - d. States the facts relied upon for the basis of the grievance;
  - e. States that the exhibitor or representative will cooperate with the investigation of the grievance and that the exhibitor or representative will be available and agrees to attend any hearing held to resolve the grievance at the time and place directed by the Grievance Committee;
  - f. Includes the names of supporting witnesses, with accessible phone numbers;
  - g. Describes or attaches any documents relating to the grievance.
21. Once the Grievance Committee has ruled on a decision; no additional grievances will be considered relating to that incident.

## **4-H Code of Conduct**

Idaho families and youth trust the University of Idaho Extension system to provide educational programs in a safe environment for all participants. The opportunity to participate in and/or work with University of Idaho Extension's 4-H Youth Development program is a privilege and honor, not a right. Volunteers are to be positive role models. Youth and parents/guardians are expected to demonstrate appropriate behavior at all times. Anyone in the immediate family, or those with a close enough relationship to the child or family or involvement in the program who has the ability to affect that student's participation in the program, or ability to cause a violation of the code of conduct is expected to abide by it. The following Code of Conduct has been established as the foundation for all individuals participating in the University of Idaho Extension programs. All University of Idaho 4-H Youth Development program participants are expected to:

- Work with youth, families, volunteers, and Extension personnel in a cooperative, courteous, respectful manner demonstrating good sportsmanship and behaviors appropriate for a positive role model.
- Accept supervision from Extension personnel and cooperate with others; parents and youth will also accept supervision from certified organizational and project volunteers.
- Maintain open, honest communication with members, volunteers, parents, and Extension personnel.
- Uphold every individual's right to dignity, appropriate self-expression, and individual development.
- Refrain from verbal, physical, or emotional abuse of others (via bullying, texting, social media, etc.) and report such abuse if observed. Any actions, such as a conviction for child abuse or neglect, violent crimes, unethical behavior, substance abuse, verbal abuse, physical abuse, mismanagement of 4-H funds, or other serious offenses, will not be tolerated.
- Respect, adhere to, and enforce the rules, policies, and guidelines established at the county or local program and state levels for the 4-H Youth Development Program and all applicable University of Idaho policies.
- Promote the spirit of inclusion and welcome participation of other individuals from all backgrounds. Comply with equal opportunity and anti-discrimination laws.
- The consumption of alcoholic beverages, the use of tobacco products, or an illegal controlled substance at 4-H youth events is prohibited.
- Inform Extension personnel of any incidents that may violate 4-H policies.
- Treat animals humanely and encourage all participants to provide appropriate and ethical animal care.
- Operate machinery, vehicles and other equipment safely and responsibly when working with youth and adults participating in 4-H Youth Development programs.
- Ensure that 4-H participants are not required to purchase materials, equipment, animals, or services from any specific places of business.
- Comply with all applicable laws of the city, county or local program, and state of residence and/or location of 4-H activity.
- Handle all concerns regarding county or local 4-H program management internally within the University of Idaho Extension system.

Violating the Code of Conduct shall be grounds for action up to or including immediate removal from the 4-H activity/program and termination. Decisions regarding immediate removal, suspension, or termination will be made by the county or local program 4-H Professional with subsequent notification of and consultation with the District Director and State 4-H Youth Development Director. The process of resolving issues with volunteers, parents and youth is outlined on page 19 of the Idaho 4-H Youth Development Policies and Procedures Process for resolving 4-H volunteer (parents and youth) Issues. Those who wish to appeal a decision may do so through the Appeal Process.

## 4-H Table Decorating Contest

**Monday, July 21, 3:00 - 7:00 p.m.**

O'Connor Fieldhouse

All youth enrolled in Canyon County 4-H are encouraged to participate in the 4-H Table Decorating Contest. Limit to one entry per 4-H member. Exhibitors will check out a 24" X 24" place setting board during 4-H project interviews. Exhibitors will need to bring the table setting board on Monday, July 21 between 3:00-7:00 p.m. in O'Connor Fieldhouse and set up display then. A poster presentation of a table setting will be accepted for Cloverbuds only. Poster must be 24" X 24".

Table Setting must follow one of the following "Meals":

- 1 - Breakfast
- 2 - Luncheon
- 3 - Dinner
- 4 - Special Occasion

Rules:

Table Setting must be assembled by the 4-H member only. Boards are to be covered. Covering will represent the table linens. Runners may also be used, but all of the display board must be covered. Place settings must contain a napkin. No disposable/paper tableware. No real flowers or real food may be used on the table display. All decorations must be on the display board. Height of centerpieces must allow for a clear view of the dining partners. Entry must include one place setting, centerpiece, and menu.

*Menu:* Is part of the table display and will be considered for judging. Menu must be printed on a 3 x 5 card or in another attractive legible manner. Menu should reflect the meal time or occasion. Menu should be easy to read and visible. Food items should be balanced, offering sufficient dishes from all food groups. A minimum of three courses should be served.

*Flatware:* Flatware should be arranged in the order of its use for the various courses. Set no more than three pieces of flatware on each side of the plate. If a steak knife is needed for the meal, a dinner knife should be used and labeled steak knife.

*Tableware:* set all courses served according to menu with the exception of dessert. Salad plate (if needed) may be set to the left of the forks or on top of the dinner/meal plate.

*Glasses:* place setting must show the type of glassware needed to accompany the meal listed on menu.

*Centerpieces* may not be a ready-made centerpiece from a store.

Please use Modern American Standards and Guidelines for table settings (vs. Europe Standards).

Awards will be announced at the 4-H Awards Ceremony for FCS and Miscellaneous exhibits at 5:00 p.m. on Friday, July 25 in O'Connor Field House.

### **Preparation of Sewing Exhibits:**

1. All exhibits will be provided a label at exhibit check in. The information on the labels will be generated from online fair entries. Please confirm accuracy of all entry information before submitting entry.
2. Posters and displays must meet specific project requirements.
3. The 4-H member may display either: A record book portfolio including involvement report, project book, project manual, story, skills checklist and any supplemental records OR a 4-H clothing construction portfolio including involvement report and skills checklist.
4. Projects that require notebooks or reports as part of the exhibit requirements must be checked in with exhibit and not included in the record book portfolio.
5. Garments that have been worn should be carefully laundered and pressed before exhibiting.
6. Dresses, skirts, blouses, trousers, etc., should be brought on hangers and must be in clean, clear plastic bag or garment bag. Other sewing entries (non-clothing) should also be presented in clear plastic bags.
7. No accessories are to be exhibited with clothing project.

6. Recipes and their source must be included with all food exhibits.
